# **Coding and Reimbursement**

Devices provided by MyndTec do not have a unique reimbursable code. A therapist would bill one of the following codes for the patient's treatment. Most of these are billed in 15 minute increments, based on the length of the procedure.

# Canada:

### Government-funded physiotherapy services.

Some hospitals in Canada have outpatient clinics with rehabilitation programs for patients recovering from stroke or an injury. #### **Assistive Device Program (ADP)**

Under the Assistive Devices Program the Government of Ontario helps cover the costs of reciprocating gait orthoses, specifically hip-to-foot brace systems that support and condition muscles and joints used to walk.

In addition to the above, you must have **primary or secondary lymphedema**, **or hypertrophic (raised, burn-related) scarring**. (Pumps are funded for primary lymphedema only.)

Patients already receiving support from WSIB or Group A veterans already covered under Veteran Affairs Canada do not qualify for the ADP.
